



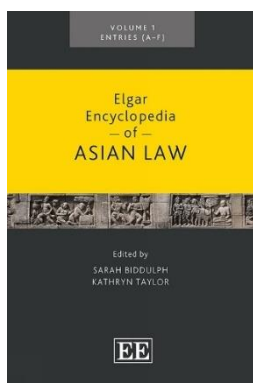

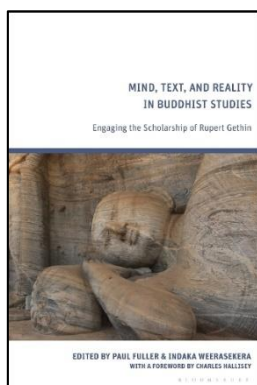

Essays include explorations of Buddhist teachings, scriptural studies and cover the fields of research that engage Rupert Gethin's scholarship: Buddhist cosmology, textual translations, Abhidharma and the interface between Buddhism and modern science.

Scholars address themes associated with Buddhist thought and practice, including philosophy of mind and the relationship between artificial intelligence and Buddhist ethics. 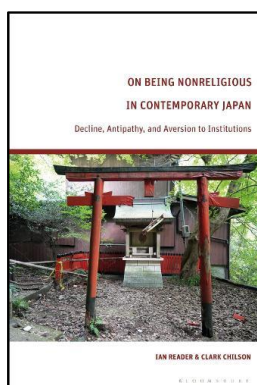

Challenging the notion of the nonreligious in Japan being religious through tradition and institution, this book demonstrates how negativity and antipathy for religion relate to religious decline in Japan today. Why do most Japanese say they are 'nonreligious' (mushukyo)? Since the 1990s, scholars have answered this key question for understanding religion in contemporary Japan as follows: although the Japanese say they are nonreligious because they do not identify with a particular religious tradition or institution, they are in fact religious through their traditional practices; New Year's visits to shinto Shrines, Buddhist mortuary rites and festivals (matsuri) are typically seen as customs rather than as religious.

Challenging this answer, this book argues that many Japanese say they are nonreligious because they actually dislike religion and want to distance themselves from it. To support this argument, the book explores how religion is in decline in Japan today. Demonstrating how negative images of religion are produced in the mainstream media, in popular culture, and by various groups and people, this book also explores specific case studies such as anti-cult organizations, lawyers, government agencies, intellectuals, and religious organizations.

Ian Reader and Clark Chilson argue that popular negative images and perceptions about religion create an 'ecology of dislike', which encourages disassociation from religion and exacerbates problems for religions today. Overall, this book provides a new perspective on religion in contemporary Japan that has implications for our understanding of secularization in the modern world.



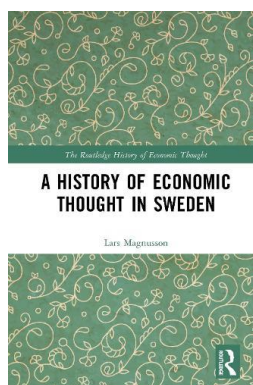

Situating key texts and writers in their proper historical context, this book presents a history of Swedish economic thinking from early modern times to the present day.

Highlighting key elements of Swedish political, economic and social history allows the book to shed new light on important parts of the story including the development of neo-classical economics from the late 19th century - associated with leading names such as Knut Wicksell, Gustav Cassel and Eli Heckscher - and the rise of the so-called Stockholm school in the 1920's and 30's. But the book also goes back further to explore the Swedish economic literature of the 18th century, particularly its more "liberal" version of mercantilism and cameralism, as well as early modern and medieval developments. Throughout, the book emphasizes the unique nature of much of the economic thinking emanating from Sweden. Emulation and adaption of political economic thinking imported from abroad - primarily the UK, France and German speaking countries - is an important part of this story, but this is shown to be an active process which has resulted in great originality in Swedish economic thought.

This book will be of interest to readers in the history of economic thought, economic history, the history of ideas and Swedish history.

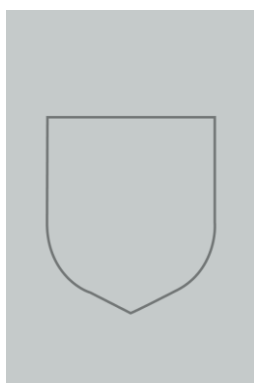

What causes cyclical downturns that wreak havoc on our lives? Most economists will say that they result from random external shocks and that, without these, the economy would sail along beautifully. In US Business Cycles 1954-2020, John Harvey argues that overwhelming evidence points to an internal dynamic, one related to the behavior of economic agents that generates what we call a business cycle. He draws on the work of past Post-Keynesian and Institutionalist scholars to create a current theory of business cycles, one that treats them as systemic and not the result of random chance. He addresses not only unemployment and bankruptcies that are the immediate consequence of the business cycle, but critical social challenges like climate change and elderly care. Examining an extensive history of US fluctuations, Harvey fills a long-standing void within the discipline by offering an alternative theory of income, employment, and price determination.

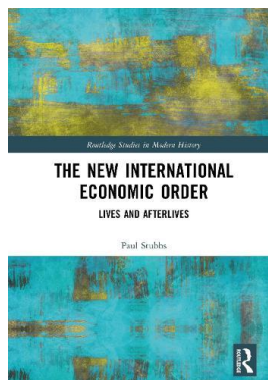

The New International Economic Order (NIEO) was an attempt, underpinned by the agency of the Global South, to articulate global economic and social rights consequent upon political rights gained through processes of decolonisation. *The New International Economic Order: Lives and Afterlives* situates the NIEO within the interregnum of the 1970s, addressing its core features, intellectual antecedents, contradictions, absences, and afterlives. Particular attention is paid to the role of the Non-Aligned Movement (NAM) alongside the G-77 and UNCTAD. The book traces the orchestrated United States opposition to the NIEO and the growth of neoliberalism at the end of the 1970s before discussing some of the NIEO's many afterlives. It argues that analysing,

translating and adapting the NIEO is important for any re-envisioning of emancipatory global economic, political and social relations today.

Using a mixture of documentary and archive material, *The New International Economic Order* will be of interest to students and researchers in diplomatic history, international relations, development studies and sociology. It brings together a large number of themes that are not usually considered together in the existing literature, combining theory and empirics in innovative ways.

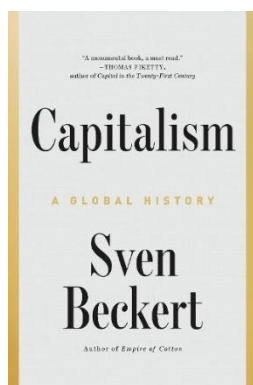

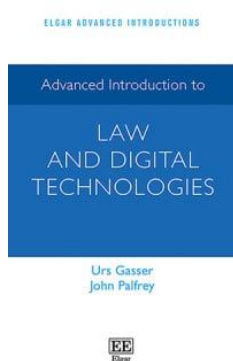

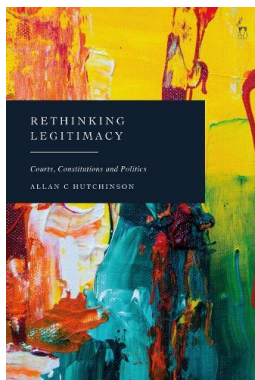

This book presents a new perspective on the debate around legitimacy, politics and constitutional law in Supreme Courts.

Moving away from the troubling perception that Supreme Courts are trampling on the wrong side of the law/politics divide, it accepts and defends the critical claim that constitutional law is intrinsically and inescapably politics: in style, substance and outcome.

It explains what is involved in that claim and recommends a more nuanced and compelling account than it is caricatured to be. The book proceeds to demonstrate how the legal and judicial process can proceed if the law-is-politics critique is taken seriously. Insisting that it cannot be business as usual, the author offers a series of constructive proposals about how constitutional law and judicial decision-making can continue in anything like their present format and style.

Recognising that a more radical approach could be taken to the way in which democracy might re-organise, the book runs with the idea that it is possible to incorporate and accommodate the law-is-politics argument within a governmental system of constitutional democracy that resembles closely what now occurs. In that sense, the book is both critical and constructive as well as principled and pragmatic.

The archaeological park of Pompeii is one of the most famous sites of destruction anywhere in the world. From the time of the eruption of Vesuvius in 79 CE until the eighteenth century, Pompeii and its neighbor Herculaneum lay preserved under a thick layer of volcanic material. Since excavations began three hundred years ago, Pompeii has been revealing the secrets of its victims and the ordinary shape of their lives prior to the catastrophe. But did anyone survive the disaster?

In popular culture, the eruption is viewed as an apocalyptic event in which everyone died, while scholars generally assume that some escaped. Steven L. Tuck settles that debate. He starts by establishing the circumstances and timeline of the eruption and the evidence that people at both Pompeii and Herculaneum had the chance to escape the eruption. From there, he moves to the search for survivors. Using evidence from inscriptions supported by archaeological, documentary, and literary sources, Tuck finds survivors in twelve different communities and uncovers details on how they rebuilt their lives, livelihoods, and identities after fleeing the volcano. While some survivors integrated quickly into their new communities and used their new city's name in the personal names of their first generation, others preserved cultural markers from their destroyed communities through language, religious dedications, and renewed businesses. Many of the families that escaped intermarried with other refugee families, but also ran for public office in their new cities, made generous donations to their communities, and integrated while maintaining their former identity. Some refugee families came to the aid of the less fortunate by taking in poor and orphaned survivors, while others married beneath their previous station. The Roman government responded to the needs of the refugee communities with new housing, infrastructure, and services, but, as Tuck demonstrates, the real work was done by the refugees themselves. By asking new questions about Pompeii and innovatively examining the evidence, *Escape from Pompeii* proves the survival of Pompeians and Herculaneans after the eruption. It sheds new insight into their lives, pre- and post-eruption, and provides new conclusions about the Roman world and its response to unimaginable suffering.

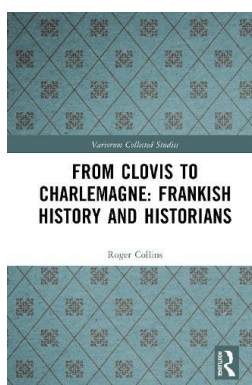

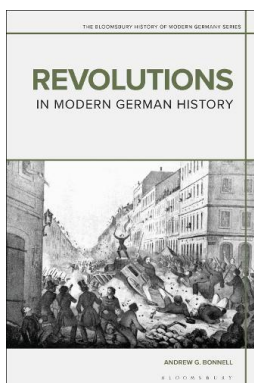

Der renommierte Zeithistoriker Norbert Frei schildert in seiner schlanken, elegant geschriebenen Biographie Leben und Leistung des ersten Bundeskanzlers aus der Perspektive der Gegenwart. Er beschreibt Adenauers politische Stationen vom Kölner Oberbürgermeister der Weimarer Republik über die Zeit des Dritten Reiches bis zum zupackenden Gründungskanzler. Vor allem aber analysiert Frei Adenauers Politik nach der deutschen Katastrophe: die unbedingte Westbindung, die er gegen zahlreiche Widerstände und Hindernisse durchsetzte, aber auch die gravierenden Versäumnisse bei der Entwicklung einer demokratischen politischen Kultur. Frei stellt uns einen konservativen Katholiken, einen autokratischen Parteiführer, einen skrupellosen Taktiker, einen weitblickenden Europäer und einen seinem eigenen Volk mit viel Skepsis, ja Misstrauen begegnenden Deutschen vor: einen der großen Staatsmänner des 20. Jahrhunderts.

Hermann Göring (1893 - 1946), Reichsminister für Luftfahrt und zweiter Mann hinter Hitler, hat wie keine andere NS-Größe Ämter und Machtbefugnisse angehäuft. Andreas Molitor erzählt das Leben eines Machthungrigen, der Gegner kaltblütig ausschaltete, am Holocaust mitwirkte und – von Hitler kaltgestellt – ein bizarres Luxusleben führte. In vielsagenden Szenen und analytisch auf dem aktuellen Diskussionsstand entsteht die fesselnde Biografie eines Skrupellosen, der sich allen Erklärungen zu entziehen scheint.

Durch Görings Leben zieht sich wie ein roter Faden das Streben nach Macht und Geltung, von der Kindheit bis zur Verurteilung beim Nürnberger Kriegsverbrechertribunal und dem Selbstmord in der Gefängniszelle. Seine Grenzen findet Görings Machthunger nur bei Adolf Hitler. Ihm ist er devot ergeben. Nachdem Göring als Oberbefehlshaber der Luftwaffe im Zweiten Weltkrieg versagt hat und Hitler ihm seine Gunst entzieht, zieht er sich auf seinen Landsitz Carinhall zurück, wo Kunstraub, Jagdleidenschaft und dekadenter Luxus weit wichtiger sind als die Angriffe alliierter Bomber. Der extravagante Lebensstil hat zu beschönigenden Deutungen von Görings Rolle im Nationalsozialismus verführt. Andreas Molitor zeigt, dass der selbsternannte «Mann der Tat» mit der «Entjudung der deutschen Wirtschaft» den wirtschaftlichen und sozialen Niedergang der deutschen Juden besiegelt und bei der Vorbereitung des Holocaust eine Hauptrolle gespielt hat.
