This edited volume presents a set of essays honouring the agricultural, environmental and world economic historian, Eric L. Jones. Drawing insights from contributors spanning the social sciences, it highlights how Jones' approach was ahead of its time, illuminating the benefits of studying economic history from a long-run, comparative perspective.

In the spirit of Jones' path-breaking book *The European Miracle*, this volume is divided into two parts. The first part takes the intellectual contributions of Eric Jones as its focus, closely considering Jones' contributions to the development of a non-Eurocentric perspective of world history, our understanding of long-term social processes and Eliasian sociology, and the study of the urban built en-

vironment. The second part of the book changes tack, offering a series of detailed studies on historical and contemporary themes. Each essays in this part explicitly draws its influence and inspiration from Jones' work. These 'applied' chapters, written by leading experts, make important and novel contributions to an array of important questions: the Great Divergence, economic performance in Song China, the rise of Nazi Germany, the evolution of modern China's economic links with Australia, and the likely effect on international politics of China and Russia's current growing alliance.

This book provides a wide-ranging introduction to the works of Eric Jones, one of the most influential economic historians of the twentieth century, and illustrates not only the ongoing relevance of Jones' work, but, crucially, how contemporary researchers can learn from his approach to studying long-run change.







rality, religion, aesthetics and politics.







A major work of scholarship by world-renowned, prize-winning philosopher Martha C. Nussbaum, *The Republic of Love* reveals opera as a profound form of political thought--and an often-overlooked force behind the political reforms of the Enlightenment.

In *The Republic of Love*, world-renowned philosopher Martha C. Nussbaum offers a bold and original vision of opera's contribution to political thought. Drawing on her deep knowledge of classical and contemporary opera, she reveals how composers such as Mozart, Verdi, Strauss, Beethoven, and others used their music to explore the emo-

tional and ethical dimensions of human life. These works, she argues, illuminate our fundamental need for dignity, love, and freedom in the face of oppressive institutions—and they gesture toward new possibilities for how we might live together.

Nussbaum devotes the first half of her book to Mozart, who embraced a new vision of freedom, writing male characters singing in a new emotional landscape, one that elevated the freedom of others. Her readings of *The Marriage of Figaro, Idomeneo, The Magic Flute, Don Giovanni* and *Così Fan Tutte* show an artist who recognized the capacity for love in everyone, and advanced fertile ideas about how we might cultivate it in a new kind of republic. The second half of her book follows this line of thought in operas by Beethoven, Verdi, Benjamin Britten, John Adams, and Jake Heggie, and their greatest antagonist, Richard Wagner, suggesting that they all, in a variety of ways, engage in conversation with Mozart and his themes of love and freedom. Throughout, Nussbaum identifies a recurring operatic metaphor for the impulse toward freedom: the act of breathing itself.

A major work of scholarship by a prize-winning thinker, *The Republic of Love* redefines opera as a vital, if often overlooked, engine of Enlightenment ideals--and a powerful resource for imagining the emotional foundations of political life.



The assumption that only humans can engage in politics - that only humans are 'zoon politikon' - is foundational to the Western tradition of political philosophy. While there is increasing recognition of animals' moral status (both within moral philosophy and at the level of public opinion), animals are not recognized as political subjects. This carefully researched but accessibly written volume - following on from the authors' earlier book *Zoopolis* - argues that animals too have a right to politics: a right to be recognized as political subjects and agents, and as members of political communities entitled to collective self-determination. The book draws on recent scientific work on animal societies, cul-

tures, and decision-making, as well as recent work by political theorists rethinking ideas of agency and community - especially the significance of emplaced and embodied encounters and relationships to the activity of politics. Sue Donaldson and Will Kymlicka draw a picture of what it would mean to create spaces and practices, not only for politics conducted by humans on behalf of animals, but also politics with and by animals on their own terms. It then explores how this approach could inform a wide range of contemporary debates in human-animal relations, including wildlife conservation, urban planning, and animal labour.



By addressing common questions and misperceptions over the long run of Islamic history to the present day, this book is the perfect resource for all students who study religion and the history of Islam across the world.





What is distinctively American about American foreign policy? The American Way of Foreign Policy answers that question by identifying three features of the nation's relations with other countries and tracing their impact from the eighteenth century to the twenty-first.

First, from its beginnings the United States has conducted an unusually ideological foreign policy in comparison with the foreign policies of other countries. It has tried, in different ways over the years, to promote the political ideas

individual rights, political democracy, and international peace $\dot{}$ that have played a dominant role in America's domestic politics.

Second, while most countries have used political instruments to win economic benefits - the great empires that European countries conquered and then exploited over the centuries are examples - the United States has reversed this pattern. It has regularly adopted economic policies, particularly sanctions, to pursue its political goals abroad.

Third, the United States has conducted an unusually democratic foreign policy in that the American public has had much more influence over its government's activities abroad than the publics in other countries. As the book shows, public opinion has had a particularly powerful impact on questions of war and peace, at some times pushing the nation into armed conflict but at others forcing an end to it.

Concisely and clearly written for the general reader, The American Way of Foreign Policy explores the origins of these three enduring features of the nation's foreign relations, shows how they have made themselves felt from the founding of the republic to the present day, and assesses their contributions to the successes and failures of what the United States has accomplished abroad. It provides readers with a new understanding of how and why America has conducted its relations with the world over 250 years.

This book explores the impact of the Board of Trade upon the British state from the early seventeenth century to the early twentieth century. The study argues that for too long historians have overlooked the Board, yet it was a critical force in shaping the British state and in developing its capacity both for economic regulation and for economic development. Focusing on the slave trade and on the textiles, shipping, and infrastructural industries, the authors examine the Board of Trade's role in shaping, promoting, and protecting these industries and thereby in defining the British state's economic interests.

The book adds the notion of an imperial-corporate state to widely used concepts of fiscal-military and mercantilist state-building. Challenging the adequacy of the many theories which emphasise taxation

and currency in state-building, this study stresses the importance of micro-economic interventions. It unpacks the distinctive character of the British state's system of micro-economic governance by tracing one central department's evolution and its relations with other departments, British businesses and infrastructure, and with the governance structures operating between state, company-states, colonies, and domestic business. Three sub-periods of the Board of Trade's history are distinguished, each marked by a distinctive relationship with the domestic and imperial economies and by characteristic approaches to regulatory oversight.

The book will be of interest to academics and students in business, economic, and political history, and all those interested in the structure of the British state, its legacies of running empires, its relationship with industrial policies and industrialisation, and how it developed its regulatory shape.



This book aims to provide insights regarding business management and corporate expansion in Germany from the late 19th century until the end of World War II (periods of the Second Reich, the Weimar Republic, and National Socialism) from the perspective of comparative management studies. This book elucidates Germany's specific development through analysis from two viewpoints. The first perspective is the historical context of the global economy and German capitalism. The second viewpoint concerns international economic relations-such as linkages in both market and capital-as well as influences of hegemonic nations and Germany's pursuit of globalism. This book utilizes a comparative perspective among industries, enterprises, and the United States. It is the first to comprehensively explore various fields related to business administration, including business concentration, management systems, production systems, corporate strategy, and organizational structure. This book considers (1) the concentration of enterprises and the corre-

sponding system of industrial concentration, (2) the labor management system and the deployment of the Taylor system, (3) the deployment of the Ford system and the transformation toward mass production, and (4) changes in enterprise and organizational structures. This book analyzes the development of business management in Germany, focusing on the interrelationships between (1) the factors determining business management changes, (2) the actual conditions of business management changes, and (3) the significance of such phenomena for developing companies and a capitalistic economy. This book investigates the interrelationships among three areas (enterprise, industry, and economy) to clarify the historical process of corporate expansion. 





Money in political campaigns is a subject of endless current interest and enormous consequence for American democracy. Beginning in 1976, in *Buckley v. Valeo*, the Supreme Court established a framework for public campaign regulation that declared that money constitutes "speech" and that the only constitutional basis upon which the government can regulate money was to prohibit corruption or the appearance of corruption. The Court then defined corruption narrowly and held that direct "contributions" to candidates could be limited on that basis but that "expenditures," by political candidates and others, could not. Over time as the role of money became more and more serious in politics the Court in a number of decisions seemed to be turning more willing to accept

regulation. But in *Citizens United v. Federal Election Commission*, the new conservative Supreme Court sharply turned against permitting regulation, including of corporations.

Today that regime of nearly full protection for anyone spending virtually any amount of money for or against candidates and issues remains securely in place. The question, after a half century of this system, is whether this interpretation of the First Amendment is sound or not. If yes, then what are the justifications and what will be the consequences? If not, then what are alternative interpretations and what would the world be like under each one? The contributors, all scholars and experts in this area, give their interpretations and proposals.

In Great Power, Great Responsibility, Michael Poznansky explores how the LIO has influenced US foreign policy from its founding to the present.
