

The English language accounting history of double entry accounting before 1800 has reached an impasse. The doors to its reawakening are fiercely guarded by combination locks powered by confirmation bias and adherence to a priori wisdom requiring vast amounts of supportive scholarship to make public the smallest contribution to what is known and understood of the first 600 years of its use. To open those doors, a foundation is needed upon which scholarship can begin anew - a framework of reference that can be used to justify the validity and relevance of scholarship and discovery in this field. That is the purpose and role of this book. It does not focus on the technical. It focuses on the environ-

ment and context of use of the method, and its function. It considers 'why' and consequences. It asks who, when, where, and what, along with 'how'. It adopts the perspective that the reason for the bookkeeping drove how it was adopted, not the availability of parchment or paper, nor the emergence of the concept of the technology - the book - in which it was recorded. Rather its use was driven by a need of the person who wrote the record, or by the needs of those who wished a record to be kept. A critical traditional historical method is adopted. Explanations are sought and identified utilising knowledge of the environment and context of practice that, to this point, rarely if ever feature in the antiquarian historiography this book ideally seeks to replace. The approach adopted is multi-disciplinary and the sources used are multi-disciplinary and multi-lingual. This book is essential reading for anyone with an interest in accounting's past.



This book is intended for graduate instruction in subjects like econometrics, economics, environmental science, social science and many other fields, at the Masters or PhD levels. It can be used as a textbook or as a reference guide. It covers a wide range of topics related to tools used in cross-sectional, time series and panel data. There are several aspects in which this book departs from traditional treatments. The emphasis is on understanding the main issues, concepts and methods in Econometrics, how to implement them and interpret the results. The mathematical aspects are kept to a minimum as the aim is to provide an intuitive understanding of how various parts fit together, as opposed

to a sophisticated mathematical treatment of the subject. Many examples and discussions are provided. Hence, minimal mathematical pre-requisites are needed. Extensive references are also provided to dig deeper into the mathematical aspects of the theories.

Volume 1 deals with the main methods used for inference and hypothesis testing which are applicable to both time series and cross-section data within a unified framework, with special emphasis on how the conditions and methods differ for each. It also includes a discussion of methods applicable only to a cross-section of data (usually a random sample) and to panel data with a small time-dimension. Cases with a large number of predictors are also covered

The second volume deals with various estimation and inference methods applicable when using time series data or with panel data having a large time-dimension. The treatment covers both stationary and non-stationary (i.e., unit root) data as well as long-memory processes. Also covered extensively are issues related to structural change including estimation and inference methods with stationary and/or non-stationary data, related issues in the context of forecasting and methods to address the interplay between changes in trends and unit roots.







This book delves into a developing area of Japan's labor migration studies, providing comprehensive insights to unveil the complexity of Japan's Technical Intern Trainee Program (TITP), not only from the perspective of the receiving country but particularly from that of the sending country. In doing so, the book focuses on Indonesia's participation in the TITP.

With this, the book investigates the roles of various actors, including the Indonesian government, the supervising organization, the Indonesian community, alumni, and the trainees themselves. It examines, through three different (but interlocking) stages, (1)

the pre-departure stage, (2) on-the-program stage, and (3) post-program stage.

To achieve this, the book draws upon extensive fieldwork, including in-depth interviews where the main part of the book is the result of ethnographic fieldwork, netnography, interviews, and participant observation of the relevant parties to gauge what issues/problems they are aware of. Fieldwork was conducted on/off sites and also with current and former alumni of the technical trainee program in Indonesia as well as interviews with the stakeholders, such as policymakers from Japan and, particularly in Indonesia, and the supervising organization (kumiai/kanridantai).





Europe is going through a period of major political change. Governments are taking unusually long to form, elections are becoming more unpredictable, political systems are increasingly fragmented, the radical right is gaining strength, and trust in politics is eroding across large parts of society.

This book examines how these trends have played out in Belgium by taking a long-term view from 1830 to today. While Belgium's political system and its main actors have changed significantly over time, some underlying patterns have remained.

By looking at shifts in political life, institutions, and key players since independence while using the major cleavages that have shaped political debate, the author identifies six key phases in Belgium's po-

litical history: 1830–1893, 1894–1918, 1919–1945, 1946–1965, 1965–1999, and the early 21st century.

Each of these periods is explored in detail. As with any timeline, the boundaries between the phases are not rigid. Still, it is essential to adopt a dynamic approach that recognises continuity and the turning points that have shaped Belgian politics.
