Chapter contributions focus on important pioneers of theoretical or political Keynesianism, such as Erich Schneider, Andreas Paulsen, and Karl Schiller in Germany, Kurt Rothschild in Austria, Gottfried Bombach in Switzerland; the influence of Keynes on other economists; and the relevance of Keynesian ideas in Austria and Norway.

Providing a survey of important theoretical economists in post-war Germany, this volume will be of interest to researchers and students of economic policy, contemporary political, social and economic systems, history of economic thought and political history.





In this updated edition, Angelika Nussberger provides a comprehensive introduction to the Court, examining its mission, structure, procedures, and evolving jurisprudence. The book explores how the Court has become a cornerstone of modern international and human rights law, while also facing mounting internal and external pressures. These include a surge in applications, political resistance to external criticism, and challenges in maintaining neutrality on contentious issues like migration and criminal justice. It also addresses tensions with national courts as well as attacks on the Court's authority by various actors. This second edition also examines the impact of Russia's cessation as a party to the Euro-

In *The Treatise of Human Nature*, Hume argued that we are *normative animals*, and he treats human nature in the context of, and on a par with, non-human nature. In Norms and Nature, Jay L. Garfield argues that Hume was right, and to demonstrate and explain this fact, he shows how the animals that we are construct norms, learn to conform to norms, and how we are transformed by the normative structures we come to inhabit. Garfield draws on the work of the American psychologist Edward Chace Tolman, who argued that the intentional could be naturalized without reducing it to the non-intentional and in the thought of those philosophers who shared that vision, including those in the Prasangika Madhyamaka tradition, as well as Nietzsche, Schopenhauer, Dewey, Wittgenstein, and Sellars.

Norms and Nature examines what it is to be human in the full sense of the term: to be an organism that only comes to self-consciousness in virtue of being thrown into a world already pregnant with meaning; meaning that can only be constituted collectively. To be human is to be one whose very being is constituted both by the web of customs into which we are born. In this investigation, Garfield shows how much of our existence as persons depends upon a set of interlocking virtuous spirals that enable the development of the communities that make normativity possible, and on the development of the sets of norms that enable those communities to sustain themselves. Garfield argues that it is this very aspect of our nature which provides hope that we can improve ourselves. Norms and Nature offers a rich sense of our place as a species in the natural world, and of our places as individuals in the context of the social order that we create, and that in turn create us.





This book revitalises the labour theory of value as a framework for determining production prices and explores its implications for economic theory and policy. Through an in-depth review of economists such as Adam Smith, David Ricardo, Karl Marx, and Piero Sraffa, it uncovers that the profit distribution in proportion to material costs generally prevents the division of labour between separate industries. Instead, it reveals that profit sharing in relation to the labour input - the original productive power - is the only consistent method to establish an equilibrium under conditions of 'free'

competition. In addition, profit maximisation in the vertically integrated wage sector, which satisfies demand financed out of wages, leads to a 100?% rate of profit (or rate of exploitation). The associated real unit labour costs amount to 50?%. The remnant 'lux-ury' department must adapt to this level. Empirical evidence confirms this finding. The author demonstrates that economic theory grounded upon the law of value can offer welfare-enhancing policies. Feminizing Political Institutions considers representation from a new perspective by looking at how changes within the demographic composition of a political institution can change the way citizens think about and engage with politics. It argues that the recent gains made in women's representation across all levels of government has the potential to undo the "white-masculine" stereotypes long associated with political institutions. The book advances and tests an original theory of *institutional stereotype change* that connects levels of women's descriptive representation to the stereotypic perceptions people hold of political institution. People see political institutions through a lens of masculinity,

and the masculine lens of politics limits the participation of women, feminine-typed individuals, people of color, and other minoritized groups. The author argues that when women's descriptive representation increases so that there are more women serving in elected political office people will start to associate political institutions with more feminine qualities. People not only see political institutions as masculine, but people see institutions through the lens of white-masculinity.

The book posits that the presence of more women of color in political institutions can have a particularly potent effect when it comes to breaking down the raced-gendered stereotypes associated with politics; it empirically tests how women's descriptive representation changes the masculinity of politics and how women of color's descriptive representation changes perceptions of white-masculinity. This book, therefore, shows that women's descriptive representation shifts the stereotypic perceptions of political institutions.
