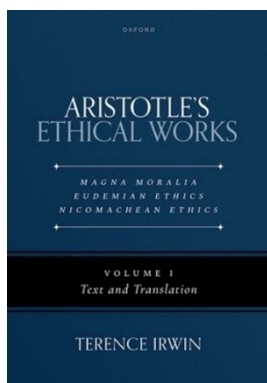

Terence Irwin examines Aristotle's three ethical works—the Magna Moralia, the Eudemian Ethics, and the Nicomachean Ethics. This collection is the first in English to study all three texts in detail and compare them systematically. Aristotle's Ethical Works argues that we can trace a development in his thought by analysing these texts. The main elements of Aristotle's moral philosophy are shown to be common to all three works, but their exposition and defence becomes clearer and more convincing in his later discussions. While the Nicomachean Ethics is the clearest account of Aristotle's ethics, we can understand its position better by seeing how Aristotle arrived at it. This is the first English commentary on the Greek text of the Eudemian Ethics and Magna Moralia, as well as the first work in English to examine in detail the questions about the

authorship of the Magna Moralia. The conclusion, that this is Aristotle's first work on ethics, is defended throughout the Notes and Essays. The Notes on the Nicomachean Ethics also provide the first English commentary for over a century.





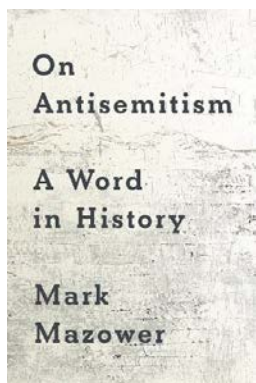

What are we talking about when we talk about antisemitism? For most of its history it was understood to be a menace from the political Right, the province of ethno-nativists who built on Christendom's long-standing suspicion of its tiny Jewish population and infused it with racist pseudoscience. When the twentieth century began, the vast majority of the world's Jews lived in Europe. For them, there was no confusion about where the threat of antisemitic politics lay, a threat that culminated in the nightmare of Nazi Germany and the Holocaust.

Now, in a piercingly brilliant book that ranges from the term's invention in the late nineteenth century to the present, Mark Mazower argues the landscape is very different. More than four-fifths of the world's Jews live in two countries, Israel and the United States, and the former's military dominance of its region is guaranteed by the latter. Before the Second World War, Jews were a minority apart and drawn by opposition to Fascism into an alliance with other oppressed peoples. Today, in contrast, Jews are considered "white," and for today's anti-colonialists, Israel's treatment of the Palestinians has become a critical issue. The old Left solidarity is a thing of the past; indeed, the loudest voices decrying antisemitism see it coming from the Left, not the Right.

Mazower clearly and carefully shows us how we got here, navigating this minefield through a history that seeks to illuminate rather than to blame, demonstrating how the rise of a pessimistic post-Holocaust sensibility, along with growing international criticism of Israel, produced a gradual conflation of the interests of Jews and the Jewish state. Half a century ago few people believed that antisemitism had anything to do with hostility to Israel; today mainstream Jewish voices often equate the two. The word remains the same, but its meaning has changed.

The tragedy, Mazower argues, is that antisemitism persists. If it can be found on the far Left, it still is a much graver danger from those forces on the Right chanting "Jews will not replace us" in Charlottesville and their ilk. If we allow the charge to be applied too loosely and widely to shut down legitimate argument, we are only delegitimizing the term, and threatening to break something essential in how democracies function. On Antisemitism is a vitally important attempt to draw that necessary line.



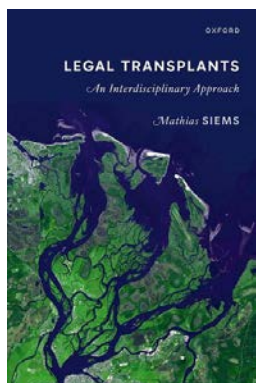

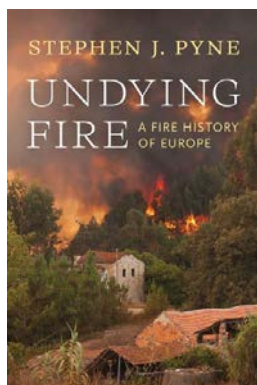

This work offers a sweeping history of Europe told through flame—and a history of fire refracted through Europe's landscapes, sciences, and empires. Drawing on and substantially updating his classic Vestal Fire, Stephen J. Pyne's incisive new volume follows fire from Iceland's oceanic fringes to the Siberian taiga and the Mediterranean's blaze-prone rim, showing how Europe's peculiar geography, history, and culture forged a singular pact with combustion. Tracking millennia of human-made fire, Pyne reveals a relationship in which Europe's elites sought to keep fire a servant, ever more tightly controlled. The transition to a fossil-fueled modernity, however, led to a paradox in which Europe lost its mastery as land use, climate, and flame turned feral and the Earth pivoted toward a Pyrocene in which humanity's binge burning created a fire age to rival the ice ages.

The result is both a lucid synthesis and a provocation: what Europe's global expansion set into motion has returned to kindle a resurgence of wildfire across the continent, starkly visible in the heat-dome summers of the 2020s. As tool, ecological process, threat, and symbol, fire illuminates Europe's past—and its environmental futures.





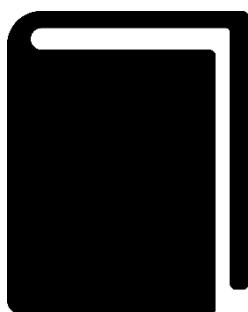

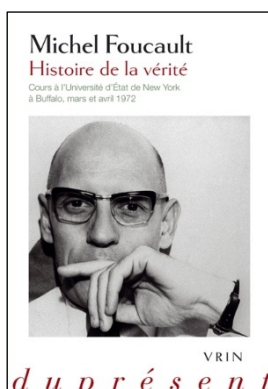

Comment s'est constituée, à travers le temps, la conception de la vérité qui est aujourd'hui celle de la civilisation occidentale? Tel est le thème de ce cours inédit prononcé par Foucault au printemps 1972 à l'Université d'Etat de New York à Buffalo. En prolongeant ses deux premiers cours au Collège de France, il étudie dans deux périodes, l'Antiquité grecque et le Moyen Âge occidental, l'histoire de la façon dont s'est opéré, à travers l'évolution des pratiques judiciaires et des relations de pouvoir qui les sous-tendent, le partage du vrai et du faux qui est à l'origine du discours scientifique occidental.

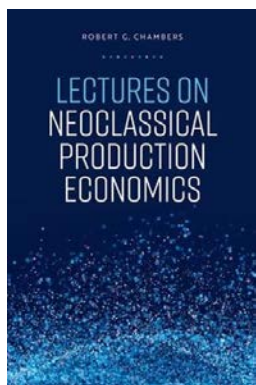

Lectures on Neoclassical Production Economics is an advanced undergraduate treatment of the fundamental economic model of producer behaviour. It shows how producers, confronted with existing technical possibilities and markets, decide how and what to produce. The book first discusses the roles that models, abstraction, and mathematics play in economic analyses. It then introduces a "canonical model" of "The Technology" as a set of inputs and output that satisfies five basic assumptions. Successive chapters build on this foundation to develop representations of technical possibilities that include production functions, input-requirement functions, input sets, and output sets. A "primer" on the optimal behaviour of price-taking, profit maximizing producers follows.

It describes in a rigorous, but accessible, form the optimal producer behaviour using verbal, graphical, and mathematical arguments. Following chapters cover cost functions, revenue functions, and profit functions. These chapters treat the theories of cost-minimizing, revenue-maximizing, and profit-maximizing producers. Concepts covered include cost-minimizing demands, revenue-maximizing supplies, profit maximizing input demands and supplies, Shephard's Lemma, McFadden's Lemma, and Hotelling's Lemma. A chapter on duality then shows that the existence of well-behaved profit function implies the existence of a canonical technology. Distance function representations of input set and output sets are then introduced and their properties are derived. The book discusses: how to use distance functions to derive cost and revenue functions, how to use cost and revenue functions to construct "dual distance functions", the role that distance functions play in calculating shadow prices, the use of distance functions to measure efficiency, and the use of distance functions to measure relative performance. The final chapter examines the consequences of relaxing the assumptions of the "canonical model" and price-taking producers.



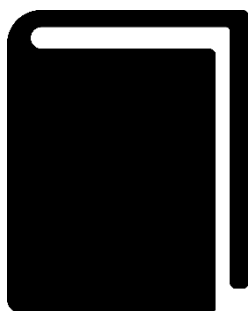

Despite the 'return of financial crises' since the end of the Bretton Woods era, a new generation of bankers hardly had any experience or any memory of a previous systemic financial crisis. The events of summer 2007 prompted investors, CEOs, and regulators to investigate the past to understand the present and foresee the future. The 2008 financial crisis strengthened the need to place financial crises in long-term historical perspectives, establish parallels, and make comparisons. Such comparisons, however, have remained sparse and generally reduced past financial crises to stylized facts in a quest for lessons that could be drawn rather than analysed their specifics. This book is a contribution of history to the study of financial crises, with a focus on whether and how the memory of previous crises has persisted, faded, or changed over time. Intertwining memory and narrative representations of the reality, it investigates the reasons why some crises have been selectively remembered and others apparently forgotten. It does so with a focus on the new era of financial instability that followed the end of the Bretton Woods system of fixed exchange rates in 1973 - a period marked by a series of financial crises (1974, 1982, 1987, 1997, among others); economic, political, and cultural changes (globalization, deregulation, formalized mathematical economics), and culminating in the global financial crisis of 2008.





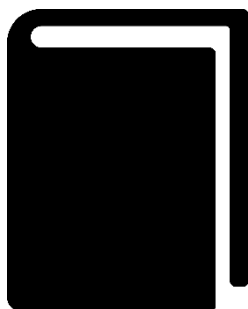

Kevin Dowd's *Totalitarian Money?* provides a comprehensive critique of proposals to establish CBDCs (central bank digital currencies) around the world. He argues that they are economically inefficient, as they provide no benefits that cannot be obtained by other means. He explains why CBDCs are dangerous to financial stability and personal freedom as they enable digital currency to be weaponised against people to comply with the political or social agendas of those in control. Dowd reveals that, despite being promoted by central banks as the next 'big thing', public demand for CBDCs is negligible and they have been rejected by the public wherever they have been introduced. Evaluating the track record of countries that have introduced CBDCs, Dowd explores the drawbacks of CBDCs and explains why the private sector is better equipped to provide a retail digital currency to the general public.



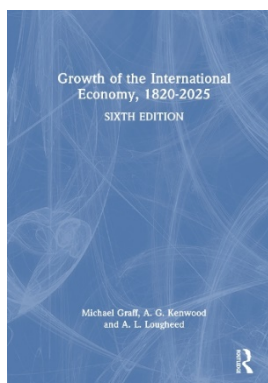

Often framed as "senseless" acts of cruelty in popular culture, the stories told by the survivors, eyewitnesses, and perpetrators examined in this book instead reveal the perpetrators' intentional use of symbolic violence to torture and kill their victims, and to undermine victim communities' social vitality in long-lasting ways.

Erin Jessee and Annie Pohlman explore four inter-related forms of symbolic violence: the destruction of the victim groups' cultural heritage; atrocities against children and elders; forms of humiliation, assault, and mutilation that target victims in gendered and sexualized ways; and atrocities intended to undermine the spiritual vitality of living and deceased victims. They argue that these forms of extra-lethal violence intentionally inflict social death by drawing on culturally specific symbols and tropes. The cases examined in this book show how perpetrators undermine or destroy the biological elements of victim groups through torture and killings, alongside the constituent parts of the victim group's social vitality: the historical, cultural, and social bonds that give meaning to and sustain communities.



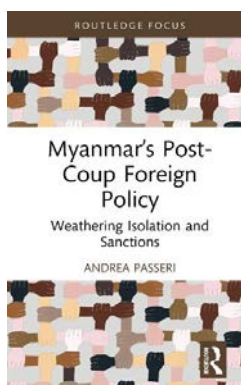
