



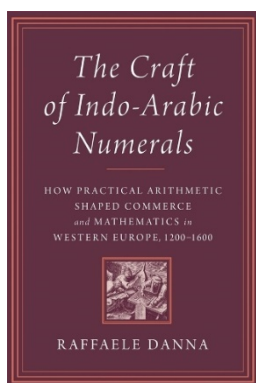

An illuminating, fine-grained account of how Indo-Arabic numerals facilitated the spread of practical knowledge in Western Europe—reshaping both commerce and mathematics in the process.

In the thirteenth-century Mediterranean, commerce transformed as merchants shifted from Roman to Indo-Arabic numerals—an alternative that better facilitated complex calculations. It has long been known that this transition stemmed from Europe's increasing exchanges with India, Persia, and the Arabic world. Yet much remains to be understood about how Indo-Arabic numerals—and the practical arithmetic they enabled—actually spread across Europe. As Raffaele Danna shows, it was hundreds of ordinary merchants, schoolmasters, and artisans who nurtured these changes, thereby driving key advances in

both commerce and mathematics.

Drawing on an original catalog of more than 1,200 practical arithmetic manuals, Danna charts the incremental spread of the new figures with unprecedented precision. While Italian merchants were the early adopters, it took nearly three centuries for Indo-Arabic numerals to become established in northern Europe. As Danna shows, adoption did not follow the routes of maritime trade. Rather, Indo-Arabic numerals moved gradually across the continent through inland networks of practitioners. Everywhere they went, the ten figures enhanced commercial practices and facilitated the emergence of a coherent language of mathematical craft. The growing social circulation of this knowledge, in turn, had a lasting impact on the economic trajectory of Western Europe. By the late sixteenth century, even academics were absorbing lessons from the vernacular tradition—a development that led to the first major breakthroughs in European mathematical theory since antiquity.

Combining economic history with the social history of mathematics, *The Craft of Indo-Arabic Numerals* illuminates the integral role of practical arithmetic in both intellectual and commercial transformations across Western Europe.

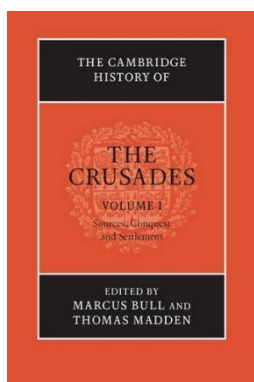

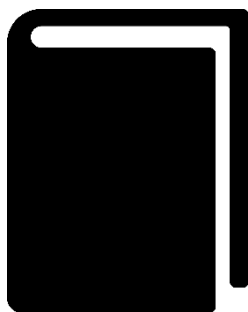

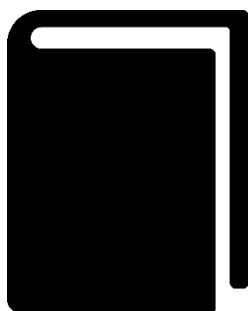

Quantitative easing (QE) is a relatively new form of monetary policy whereby a central bank buys up government bonds and other financial assets to stimulate economic activity. It came to prominence in the aftermath of the Global Financial Crisis of 2007-11 when standard monetary policy tools were unavailable to central banks due to low inflation levels. Quantitative tightening (QT) is the opposite whereby central banks sell off bonds and assets to reduce the size of their balance sheets. Quantitative Easing and Tightening brings together leading academics and practitioners to assess the legacy of quantitative easing and look at where new quantitative tightening measures may take us. It examines three of the most important actors in the QE/QT story: the Bank of England, the European Central Bank and the US Federal Reserve to provide an overview of the effectiveness, governance, and fiscal costs of quantitative easing and tightening.





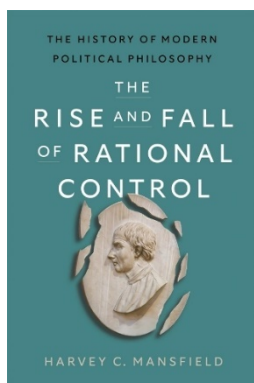

The Rise and Fall of Rational Control is a bold interpretation of centuries of intellectual revolutions. Based on Harvey C. Mansfield's legendary Harvard course, taught for decades to rapt classrooms, this volume is both a grand work of ideas and an elucidating reflection on liberalism, its eclipse, and the possibility of renewal.

Mansfield locates the birth of modern political philosophy in the work of Niccolo Machiavelli, the first to assert that the objective of politics is not to achieve wishful ideals of justice or virtue-as the ancients had it-but to manipulate the brute facts of the world in service of interests. Here rational control, free from the order of gods or God, is the key to achieving the modern order, which can liberate humans from slavery and conflict. Hobbes and Locke later develop Machiavelli's modern idea, laying foundations for liberalism. Then comes the first crisis in the form of Rousseau, who introduces historical change into the very idea of reason, which itself is said to evolve. After Rousseau, history takes center stage, as witnessed in Kant, Marx, and Hegel. The second crisis of modernity arrives with Nietzsche, who casts doubt on reason itself. Ever since, political thought has been stranded in the desert of postmodernism, where Machiavelli's necessities are replaced by faded subjectivity.

Tracing the rise and fall of rational control, Mansfield asks where we go from here. Can we progress beyond our unease with what is modern, or should we aim to return somehow to what came before?





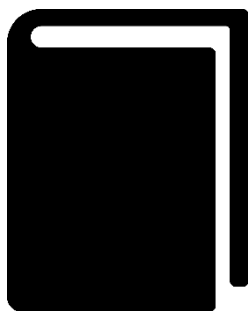

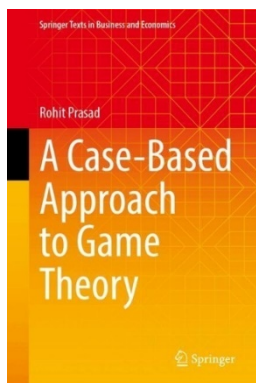

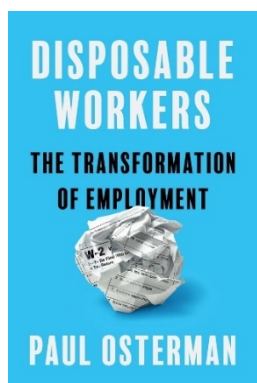

Companies cannot exist without workers, but they are increasingly reluctant to have employees. Instead of providing the benefits and protections that have traditionally come with employee status, businesses are turning to tactics that let them treat people as interchangeable parts, to be used and discarded as needed. Drawing on an original survey of over 6,000 workers, Disposable Workers reveals the striking extent of this transformation across the occupational hierarchy, affecting everyone from janitors to nurses.

Paul Osterman identifies three distinct categories of disposable workers: contractors, freelancers, and marginal employees. The marginal category, unique to Osterman's analysis, describes workers who are employees from a narrow legal standpoint but are held at arm's length by their firm—left without job security, skill training, or opportunities for promotion. Many low-

wage service workers toil in marginal jobs, but so do white-collar professionals such as adjunct university faculty and staff attorneys at law firms. When the three categories are added up, they account for more than 35 percent of the American workforce.

Not all disposable workers object to their arrangements. But most contractors and marginal employees would prefer standard employment, and there is a significant cost to their current status. In response, Disposable Workers offers a range of policy recommendations, including mechanisms to prevent over-reliance on contracting and freelancing as well as reforms to improve job quality for part-timers and marginal employees. As the deconstruction of employment affects more and more workers, the importance of such measures will only grow.

The military general who became Emperor Hirohito's prime minister, Hideki Tojo is most often remembered as an iron-fisted leader who dragged Japan into World War II and-after spectacular losses-was eventually executed as a war criminal. Yet Tojo was far more than his ignominious end. In fact, as Peter Mauch argues, he was one of the twentieth century's most accomplished military statesmen.

Over a career of some forty years, Tojo successfully launched himself into the highest echelons of political power. He was not only a tactical genius, Mauch shows, but also a savvy administrator, a fierce imperialist, and a deeply loyal advisor to the emperor. Tojo's career took off with the notorious Kwantung Army in Manchuria, where he played a key role in escalating the Sino-Japanese War during the 1930s. As he rose through the ranks, becoming minister of war and then army chief of staff, he honed the efficiency of the Imperial Army and enhanced its influence within the emperor's court. All the while, he deftly negotiated the fractious military rivalries that arose wherever he went. Brilliant, ambitious, and often ruthless, Tojo reached political heights that were perhaps matched only by his precipitous fall in the final months of World War II.

Layered and evocative, Tojo is at once a riveting military history of Showa-era Japan and a nuanced portrait of the relentless personality at its center.



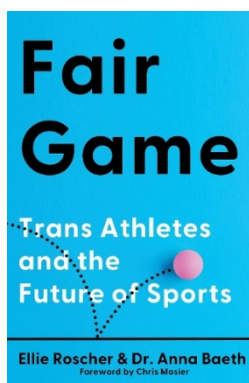

Ancient Macedonia is often synonymous with Alexander the Great. After all, his conquests stretched the Macedonian Empire thousands of miles wide, and during his reign Macedonia was without equal. Alexander and his father, Philip II, who raised Macedonia to superpower status, still dominate our perceptions of this ancient kingdom and empire. Macedonian kings before Philip and Alexander are often portrayed as their opposites--weak and ineffectual--but this book proves that this is a mistake.

While Macedonia under the Argead Kings covers the reigns of Philip, Alexander, and his immediate successors, it takes an even closer look at what life was like in Macedonia before its most famous rulers. While the literary evidence speaks of Macedonia's internal disunity during this period, as well as its dynastic upheavals, it is important to note that the authors of this literature were often Greeks, who had very different perspectives of what their enemies, the Macedonians, were like.

This book supplements the literary sources with archaeological evidence to tell a more complicated story. While the Argead kings certainly varied between successes and failures and faced their fair share of security crises, when viewed as a continuum, we see that Macedonia's earlier history was not a path of steady deterioration but a more subtle rise and fall. When the Argead kings are brought out from the shadows, we can see their importance in the kingdom's development and their influence on each another and the wider Mediterranean world.



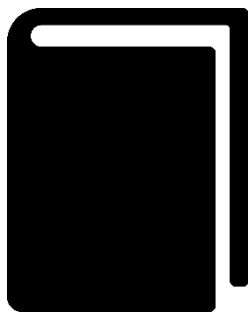

In September 1645, when the directors of the West India Company gathered for their semi-annual board meeting, they faced the most important crisis in the company's history, one that would determine the fate of a burgeoning Dutch imperial project in the New World.

In this book, Alexander Bick tells the story of this meeting, applying the tools of microhistory to the boardroom of one of early modern Europe's most enigmatic trading companies. Chartered by the States General in 1621, the West India Company's principal aim was to open a new front in the struggle against Habsburg Spain by attacking its colonial revenues at their source. This required deep and enduring cooperation between the company and the central organs of the Dutch state. Unlike the merchant-dominated ventures of popular imagination, the company emerges as an instrument of war in which noblemen, courtiers, and city and provincial magistrates played a decisive role. Through portraits of figures like Johannes de Laet and Hendrik van der Capellen, the book reveals how the company and its leaders wrestled with fundamental questions of political authority, colonial governance, and the relationship between private enterprise and public power--questions that crystalized in the fall of 1645 in the debate over the future of the lucrative but embattled Dutch sugar colony in northeastern Brazil.

Minutes of Empire offers an intimate and original perspective on the cosmopolitan politics of overseas trading companies that challenges conventional accounts of how empire contributed to the Dutch Republic's political and economic ascent in the Golden Age.
