

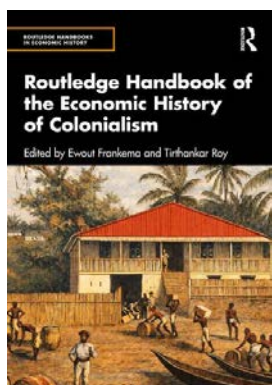

European colonial rule in Asia, Africa, and the Americas was a world-changing force and left a variety of legacies, demographic, economic, environmental, technological and cultural. The economic history of colonialism has seen an outburst of research in the last twenty-odd years; but, with many significant new works appearing in specialist journals, students and teachers of the field may still find it challenging to explain what this scholarship adds up to, its most significant claims and breakthroughs, and how it relates to older versions of the economic history of colonialism.

This handbook gathers a set of specially-commissioned essays written by leading contributors to the field which focus on the two principal waves of European colonialism since the 15th century: the first in which Europeans converged mainly on the Americas (c. 1490s-1820s) and the second in which attention was focused on acquiring control over large swaths of Asia and Africa (c. 1850s-1970s). It shows students of economic history the key facts that need to be explained about the imperial powers, the colonial experience, and why the European empires outside Europe are significant for the economic history of the world. The handbook also includes studies of the Japanese and American empires in Asia, as these were provoked by and in nature quite comparable to the formation of European empires thus providing worthwhile and meaningful comparisons.

This handbook will serve as a vital resource for research, teaching, and reference, offering readers insights into economic history, colonialism, globalization, and the forces that have shaped the modern world economy.

Grounded in Japanese philosophy and ideas of non-duality and emptiness, this is a much-welcomed contribution to central issues in philosophy of education.

Anton Sevilla-Liu uses the thought of ethicist Watsuji Tetsuro (1889-1960) and philosopher of education Mori Akira (1915-1976) to address the dangers of self-centeredness and conformism in a competitive education system. 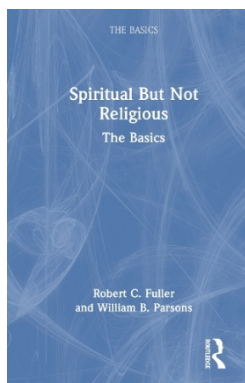

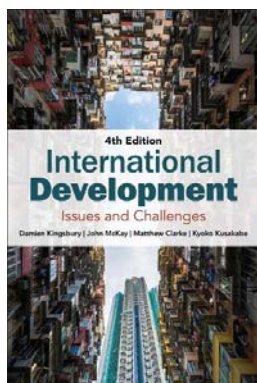

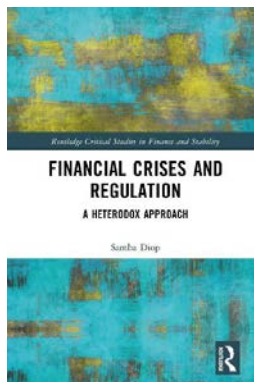

The bank failures of the early 2020s challenged the view that the financial reforms implemented after the 2007-2009 financial crisis had strengthened the robustness of the financial system.

Despite the commonly held belief that measures such as the Basel framework and Dodd Frank Act had provided the financial sector with an effective shield against disruption, this book argues that the failure of these reforms to prevent further financial crises was not inevitable. The book contextualizes the long history of financial instability, elucidating the features of capitalism's current phase that make it so prone to financial crises, and highlighting other periods (notably the post-war period) characterized by remarkable stability. The book draws on post-Keynesian analyses of the evolution of capitalism and the endogenous instability of capitalist economies - by Minsky in particular - and

incorporates insights from French regulatory theory. From this perspective, financial crises are not the result of exogenous deviant behaviors on the part of ill-intentioned or incompetent agents but the result of the normal functioning of capitalist economies. In this respect, the 2007-2009 crisis and the bank failures of 2023 are manifestations of this endogenous financial instability. Preventing their resurgence requires an alternative understanding of financial instability, one that interrogates the intrinsic dynamics of the financial system, engages in a critical examination of extant regulatory frameworks, questions the effectiveness of resolution mechanisms, and considers the increasingly urgent climate-related financial risks.

This book will be of interest to researchers working on issues of financial instability and regulation as well as money and banking more broadly.

This timely and innovative book provides an insight into the rapid growth of the wine trade in Hong Kong after the withdrawal of the import duty on wine in February 2008, and outlines Hong Kong's journey towards becoming a successful global wine consumption and trading hub that has transformed the wine industry worldwide.

The book draws on information from over 40 visits to private cellars, storages, vineyards, and attendance at seminars, tasting sessions and trade fairs, as well as other wine related events; over 70 interviews and focus groups conducted with consumers, collectors, diplomats, trade ministers, and other professionals such as auctioneers, distributors, educators, restaurant managers, and sommeliers; and a wide range of marketing material. The findings of this book have practical implications, with the aim of identifying target consumers, outlining a successful

formula for transforming a region into a wine hub, mapping the connections between key individuals driving the wine trade, and assessing the potential impact of geopolitical uncertainties on the global wine trade. The book aims to contribute to the growing academic literature on business management, global consumer culture, luxury branding and marketing, and wine research. It illustrates the growth of the Hong Kong wine trade, the development of wine education, and changing consumption practices in the broader context of mainland China and other East Asian regions, highlighting their relationship with the West. The book explores what this transformation tells us about the economic history, cultural ideology, geopolitical changes, and social transformation of the region and explores how the creation of the wine trade was driven by visionary policymakers, inquisitive consumers, and entrepreneurial individuals.

This book is relevant to courses in the field of anthropology, Asian studies, business management, geography, geopolitics, intercultural communications, luxury brand marketing, public health, sociology, tourism, and wine education, but equally importantly, it is of interest to professionals working in the food and beverage industry and related business sectors.

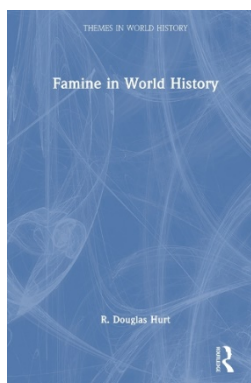

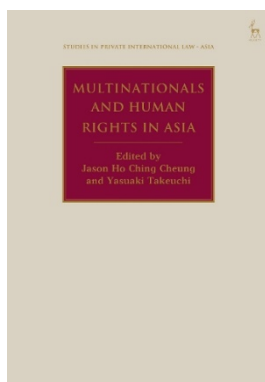

This book investigates the availability in Asian jurisdictions of civil remedies against multinational businesses for human rights abuses.

Various means have been developed in Europe and elsewhere to hold businesses accountable to victims for human rights abuses. Techniques include legislating due diligence requirements for companies operating abroad, broadening court jurisdiction to include foreign companies having subsidiaries within a country, expanding international jurisdiction, promoting universal jurisdiction, and implementing international conventions and sanctions.

On the 15th anniversary of the 2011 *UN Guiding Principles on Business and Human Rights*, the book assesses whether the norms of the *UN Guiding Principles* have taken root in Asia, which has only had a mixed record for upholding human rights. The book first considers the international state of play in the field. It moves on to case studies of corporate governance and human rights in Asia (especially Japan, South Korea, India, Thailand, and the Philippines). It then examines emerging issues (environmental damage and climate change, crimes against humanity, and compliance programs and corporate criminal Responsibility), and considers how Asia has dealt and can deal with corporate responsibility in connection with those matters. By way of conclusion, the book offers an action plan for implementing the *UN Guiding Principles in Asia*.

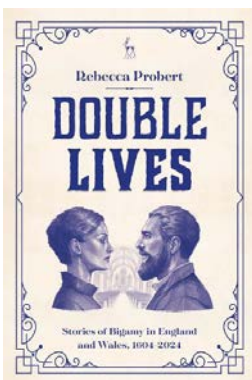

A conman advertises for a wife and then disappears with her lifesavings; he has already done the same to many other women. How was he brought to justice?

These are just a few of the hundreds of bigamous remarriages put under the microscope in Double Lives. As a companion volume to *Double Trouble: Bigamy and the Law in England and Wales, 1604-2024*, this book goes behind the law reports to reconstruct the stories of those involved. Drawing on archival sources, pamphlets, newspapers, census data, parish registers, divorce petitions and family histories, it shows the different forms that bigamy might take - accidental, consensual, deceptive or exploitative - and how bigamists' stories in turn helped to shape the law.

Double Lives shows how bigamy should not be dismissed as a comical or victimless crime. Every case had its own complex mix of desire and deception, and, all too often, heartbreak for someone.

Laruelle and Radvanyi convincingly contend that Russian Arctic development policy must take into account the economic needs of the Russian budget and the geopolitical realities of decoupling from the West and pivoting towards the so-called 'Global South'. Additionally, it must consider the heavy legacies of the past in terms of population, infrastructure, and pollution, as well as future projections regarding the impact of climate change.

The sixteen essays are expertly crafted to cover key issues including the Scottish Parliament, Reformation, religious culture, deviance, gender, artistic expression, identity, and colonial ventures. This approach provides both comprehensive coverage of main historical currents and fresh perspectives on specialized research, making complex scholarship accessible and engaging.

Aimed especially at an undergraduate readership which currently lacks an effective primer on the increasingly complex specialist literature, the book will also be of interest to general readers and other non-specialists seeking an authoritative, engaging introduction to the early modern era in Scotland.
