

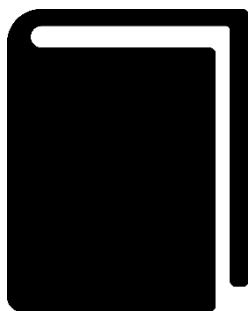

Thomas Hobbes (1588-1679) is best known as a political theorist, but also wrote about history, psychology, physics, optics and many other subjects. This volume, *Autobiographical and Occasional Writings*, edited by renowned Hobbes scholar Noel Malcolm, consists of a number of texts closely connected with Hobbes's own life and activities. Foremost among these are the two Latin autobiographies, one in prose and one in verse, which he wrote towards the end of his life. Another autobiographical text is a short book published by him in the Interregnum period, defending his conduct in the Civil War; and there is also the long Latin poem he wrote about a journey undertaken in the Derbyshire Peak District. Other writings in this volume include: a reply to a petition from the colonists on Bermuda; a legal document about a dispute in the noble Cavendish family, in which Hobbes was closely involved; a policy paper on how to win the Civil War; a love poem; and Hobbes's will.

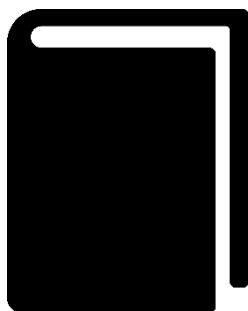

A sweeping new alternate history of Western Christianity

The Cathar Curse: Heresy and the Making of the Middle Ages opens as a corrective to the standard narrative of Medieval religious strife, one that situates the "Cathars" as the dominant countervailing force to the inexorable doctrinal grip of the Church. As Mark Pegg reveals, the 13th century Cathars were a creation of the 19th century, when scholars invented them as the central players in the grand drama of medieval repression, the romanticized and innocent victims of the Inquisition and its fanatical excesses.

In truth, the Cathars are a distraction from the larger and more compelling story of heresy in the West. "There must be heresies," Paul of Tarsus proclaimed in his *First Letter to the Corinthians*, "so that they who are of the faith may be proved." This apostolic vision of the sacred necessity of heresy fundamentally shaped Christianity from the Crucifixion to the Reformation. As Pegg shows, the paradox of Western Christianity at once needing and fearing heretics, of imagining conspiracies of dissent even when there were none, and of individuals embracing the role of heretic as a sacred requirement of free will and free speech, still shapes Western culture. Pegg's book offers a dissenting history of the Christianity in the West, one that begins with Christ and ends with Martin Luther, the Protestant Reformation, and the Spanish conquests in the Americas. Along the way, it follows the sources and progress of heretical concepts (including Gnosticism and Arianism) after the collapse of the western Roman Empire into the medieval world, where, especially after the First Crusade, an obsession with heresy gripped popes and preachers in Latin Christendom, culminating in the Albigensian Crusade and the rise of the Inquisition. Finally, he reveals heresy's central part in the dynamic struggle to reform the Church.

Compelling, epic in its scope and sweep, Pegg's book offers nothing less than an alternate history of Western Christianity.

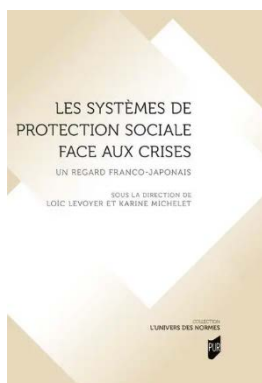

Makoto Ida hat die Verbindung zwischen der japanischen und der deutschen Strafrechtswissenschaft stark geprägt. Sein Werk steht für analytische Klarheit, systematische Tiefe und eine beeindruckende thematische Spannweite. Die Festschrift zu seinem 70. Geburtstag spiegelt diese beeindruckende Breite wider. Kolleginnen und Kollegen insbesondere aus Deutschland haben Beiträge verfasst, die das wissenschaftliche Werk und die Persönlichkeit des Jubilars in besonderer Weise würdigen.

Die Themenvielfalt reicht von **Grundlagenfragen des Strafrechts und der Strafrechtsvergleichung** über zentrale Materien des **Allgemeinen und Besonderen Teils**, das **Medizinstrafrecht** und das **Sanktionenrecht** bis hin zu interdisziplinären und innovativen Grenzgebieten des Rechts. Fragen der Normtheorie, des Bestimmtheitsgrundsatzes, der Legitimation des Strafrechts stehen ebenso im Mittelpunkt wie aktuelle Diskussionen zum Sexualstrafrecht, zu Fake News, zum Lebensrecht und zur Organisierten Kriminalität.

Besondere Aufmerksamkeit gilt den Themen, die Makoto Ida selbst in seiner Forschung über Jahrzehnte geprägt hat: **Straftheorie, Todesstrafe und Menschenrechte**, das Spannungsfeld zwischen Dogmatik und Kriminalpolitik sowie die Verantwortung des Strafrechts im internationalen Vergleich.

Diese Festschrift ist ebenso Ausdruck tiefer wissenschaftlicher Verbundenheit wie persönlicher Freundschaft.





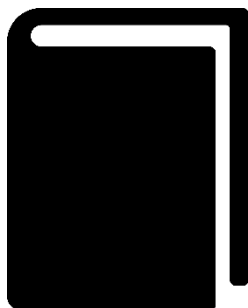

John Locke is a pre-eminent figure in the philosophical tradition. He published landmark works on epistemology, political theory, economics, education, and religion. His *Essay Concerning Human Understanding* and *Two Treatises of Government* continue to be read and interpreted across the globe. In the aftermath of Locke's death, friends and contemporaries composed memoirs of his life, character, and opinions. These became foundational for all future Locke biography and shaped the Enlightenment's reception of him. *The Early Lives of John Locke* collects memoirs by Damaris Masham, Jean Le Clerc, Pierre Coste, and the third Earl of Shaftesbury, together with those of Anthony Wood and Richard Laughton, with fragments and letters by James Tyrrell and Philip van Limborch, and an essay on Locke's writings by Pierre Des Maizeaux. 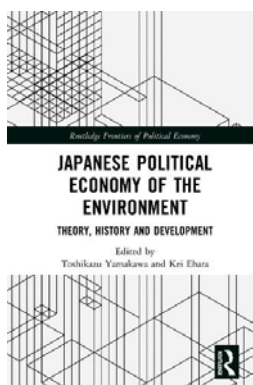

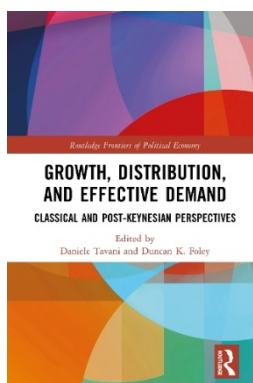

Spanning theoretical and empirical contributions in the tradition of classical political economy and post-Keynesian economics, this volume explores the relationship between economic growth and the distribution of income and wealth. The book makes a case for a rigorous empirically informed alternative economic scholarship providing more progressive and inclusive policy prescriptions than the dominant neoclassical paradigm. Mainstream economics has only recently showed interest in the problems with the distribution of income and wealth. Conversely, issues of distribution have been central in the debate among heterodox economists working in the classical and post-Keynesian tradition. The book begins by laying out "stylized facts" on the recent evolution of income distribution in the United States; it then moves to addressing the relationship between distribution, technical change, and trade in classical models, and presents a series of contributions along post-Keynesian lines on the interactions between demand and distribution, as well as policy implications. It then addresses the problems of path-dependence, hysteresis, and the potential instability arising from fiscal consolidation for economic growth, the distribution of income and wealth, and long-run growth.

This volume marks a significant contribution to the literature on alternative approaches to macroeconomics, income distribution and economic policy.

The Sources of Medieval Canon Law: A User's Guide is a comprehensive handbook for those working with medieval canon law sources of the period 1000-1500 (CE). It provides an accessible introduction to the myriad of complex legal sources used within the medieval church.

The book's primary objective is to orient non-specialists with these sources and their potential contributions to historical study, while also raising awareness of how they can be *misused*. With thirteen chapters written by experts unpicking how to evaluate and deploy these sources, this volume aims to demystify them and explain how they can be used accurately and carefully by those who are new to working with legal material. Each chapter will briefly introduce a particular type

of source and then, using selected case studies, demonstrate how such sources should be approached in order to be best-used in scholarly arguments, while also discussing the pitfalls and possibilities encountered in their use, while suggesting ways to avoid the former. Following this standard structure across chapters, the volume thus acquaints users with the sources of medieval canon law, from papal letters and conciliar canons to the paratexts and commentaries written in and for scholastically-trained lawyers, and from procedural manuals and canonical collections to local court documents.

A valuable for researchers at any level, from academics to undergraduate and postgraduate students, this book provides a critical introduction to an immense and complicated body of material.

Das Handbuch ist eine auf 12 Bände angelegte Edition des Verwaltungsrechts. Als wissenschaftliches Gemeinschaftswerk von zwei Herausgebern und rund 250 Autor*innen basiert es auf einer Gesamtkonzeption, die das deutsche, europäische und internationale Verwaltungsrecht als Einheit und in ihrer Interdependenz und Interaktion in den Blick nimmt. Band VIII ist der wissenschaftlichen Durchdringung der (gerichtlichen) **Kontrolle der Verwaltung** und des **Verwaltungsvollzugs** gewidmet. .

Die **Verwaltungskontrolle** wird in ihrer historischen Entwicklung erläutert sowie begrifflich, systematisch und rechtsvergleichend eingeordnet. Die Darstellung umfasst die Typologie der Rechtsdurchsetzung, die Analyse bestehender Kontroll- und Vollzugsdefizite, europa- und verfassungsrechtliche Grundlagen sowie die **Organisation der verwaltungsgerichtlichen Kontrolle**. Neben ausführlichen **Analysen der wichtigsten Rechtsbehelfe** werden **aktuelle sektorale Herausforderungen** an den Verwaltungsrechtsschutz wie die Kontrolle im Risiko- und im Asylrecht, die strategische Prozessführung (zB „Climate Change Litigation“) oder Ökonomisierung und Digitalisierung in den Blick genommen.
